What is the processing of your data legitimacy?

In compliance with article 6.1 of EU Regulation 2016/679 of April 27, we inform you that the legitimacy for the processing of your data is as follows:

- a) the interested party gave their consent for the processing of their personal data for one or more specific purposes and / or

To which receiver will your data be communicated?

What are your rights when you give us your data?

APPENDIX A – WEB BROWSING COOKIE POLICY

This cookie statement was last updated on April 14, 2021, and applies to citizens of the European Economic Area.

1. Introduction

Our website, https://misia.world (hereinafter: "the website") uses cookies and other related technologies (for convenience, all technologies are called "cookies"). Cookies are also placed by third parties that we have hired. In the following document we inform you about the use of cookies on our website.

2. What are cookies?

A cookie is a small simple file that is sent together with the pages of this website and your browser stores it on the hard drive of your computer or other device. The stored information may be returned to our servers or to the relevant third parties servers during a subsequent visit.

3. What are scripts?

6.1 Technical or functional cookies
